I would like to nominate Detective Sergeant Simmelink to receive the WSHNA Tom Moyer Memorial Award. It is my understanding that this award was established to recognize an individual who has made a significant contribution to the art of police crisis negotiations, and I believe that Detective Sergeant Simmelink is truly deserving of this award.

Detective Sergeant Simmelink has been on the negotiation team for the Pierce County Sheriff's Department since 2010 and became our team leader in 2018. In addition to the significant impact and transformation on our own unit Detective Sergeant Simmelink has made in her capacity as Team Leader for PCSD SWAT, her contributions and dedication to crisis negotiation on a whole truly set her apart.

Detective Sergeant Simmelink conceptualized and developed two separate training presentations that she regularly presents to FBI Basic Negotiator courses in Washington. She consistently demonstrates her dedication to train new negotiators statewide and sacrifices personal time to assist with these classes. She has even traveled several hours away and stayed with family overnight to make herself available to teach a class outside of the area.

In 2021, Detective Sergeant Simmelink organized a multi-agency Crisis Negotiation Rodeo hosted at our agency. Crisis negotiations teams from the Pierce County Sheriff's Department, the Tacoma Police Department, Pierce County Metro SWAT, the FBI, and Joint-Base Lewis-McChord attended and ran each other through complex scenarios. She included the Pierce County Co-Responders and made them available to all the teams for use as mental health consultants. Detective Sergeant Simmelink coordinated to ensure that the Pierce County SWAT Tactical Commander was also available and acting as tactical command for the scenarios to provide the most realistic training possible. The Crisis Negotiation Rodeo has since turned into an annual event and received glowing reviews by all the participants in 2022. The Rodeo is already scheduled in 2023, and with the foundation that Detective Sergeant Simmelink has laid, is sure to be a highly anticipated training regionally for years to come.

Organizing large-scale training takes a huge amount of time and energy. The training opportunity created and implemented by Detective Sergeant Simmelink has proven to be hugely beneficial to the negotiations community as it provides realistic training scenarios to agencies that may not have frequent training opportunities while also providing local agencies the chance to work together and network. Combined with the work to provide individualized training across the region, Detective Sergeant Simmelink's efforts have more than shown her to be worthy of consideration for this prestigious award.

It is with great enthusiasm and sincere praise that I make a nomination for the Tom Moyer Memorial Award. This award was established to recognize an individual who has made a significant contribution to the Western States Hostage Negotiators' Association or a significant contribution to the art of police crisis negotiations in general. I believe that Detective Sergeant Tara Simmelink of the Pierce County Sheriff's Department is worthy of consideration for this award.

I first met Sergeant Simmelink in 2010 when she became a negotiator for Pierce County SWAT. I have had the opportunity to see her excel as a negotiator and grow into a Team Leader position in 2018. During this time, I have had several opportunities to work alongside her in my role as a negotiator for Pierce Metro SWAT and as a Negotiations Team Lead for Pierce Metro TRT. I have observed her under pressure and can say she is an outstanding negotiator and an even better team leader. It is sometimes difficult to work alongside members of other teams, but Sergeant Simmelink has always made me, and members of my team feel welcomed and appreciated when we have been forced to work together in times of crisis.

Since taking over the Team Lead role for Pierce County SWAT, Sergeant Simmelink has been focused on trying to get the Peirce County Negotiations Teams to train and work together whenever possible. Sergeant Simmelink would often talk about her desire to have the teams in Pierce County train together on a yearly basis. Her idea was that if she could make this a reality, negotiators from each team would be more comfortable working with each other when a priority event forced them together. She was known for hosting training classes and inviting different teams to Pierce County SWAT's training days.

In 2021 Sergeant Simmelink organized and hosted the first Pierce County Negotiator Rodeo. She invited teams from Tacoma, Lakewood, Pierce Metro, JBLM, and the FBI to take part in a multi-agency scenario- based training event. The training included actors, mental health professionals, and command level tactical officers who were part of each scenario. Each team was tasked with providing a realistic negotiations scenario for one of the other teams to work through. At the end of each scenario, constructive feedback was provided by those involved and different ideas were presented on alternate ways to approach a certain observation. At the end of the training, there was ample time for networking and getting acquainted with other negotiators from the area. The Rodeo was a huge success and received praise from all that attended. In 2022 Sergeant Simmelink and her team hosted the Second Annual Pierce County Negotiator Rodeo and it was bigger and even better than the year before. It has quickly become a training event that each team in Pierce County looks forward to each year.

The time and energy Sergeant Simmelink has put into creating, organizing, and implementing such a large-scale training event has been very impressive. Her dedication to her team, and the other teams in Pierce County, has been very much appreciated. The goal of WSHNA is "to develop in members a higher degree of proficiency in the performance of their professional duties." WSHNA Awards Panel:

Please accept this nomination for the WSHNA Distinguished Service Award. On March 3, 2022, at approximately 9:00 am, Oregon City Police Detective Jon Neece, who is a member of the Clackamas County Crisis Negotiation Team, responded to a suicidal subject that was armed with a knife and threatening to jump off a cliff.

Detective Neece arrived and contacted the subject, who was obviously in crisis. The subject was found sitting two feet from the edge of a 100' cliff and armed with a large kitchen knife that he held to his wrist. During the initial contact, it was observed that the subject cut his wrist and was bleeding profusely from his left arm. The contact was tense as the subject threatened suicide by cop and feigned jumping from the cliff.

Detective Neece used active listening and empathy to build rapport and was able to talk the subject into small changes of behavior, such as lowering the knife and moving away from the edge. Negotiations were progressing until the subject reverted back into crisis. His demeanor changed, and he moved back to the cliff, dangling his feet off the edge. At one point, the subject raised the knife and began cutting his throat to the point where he nearly went unconscious. Again, Detective Neece used his training and experience to calm the subject. After using several TPIs and offering several cigarettes, Detective Neece was once again able to get the subject to lower the knife and move away from the ledge. After several hours of negotiating, and with the help of the subject's defense attorney, Detective Neece was able to successfully talk the subject into putting down the knife, moving away from the ledge, and crawling toward law enforcement and medical personnel. He was then transported to the hospital, where he received medical care.

As we can all imagine, this was a difficult negotiation. Detective Neece maintained his composure, relied on his training, and was able to work through an extremely tense situation. Detective Neece should be commended for his thoughtful negotiation skills and ability, which allowed this person to get the help they desperately needed.
