From Mark's original Lakewood P. D. (LPD) application in 2004, Mark began with the Pierce County Sheriff's Office (PCSO) in June of 1994 and stayed with them until February of 2004. He started with LPD that same month and began by running background checks for all ninety-nine new officers, as well as the handful of civilian staff, which was key to starting a brand new police department, LPD. During his time with PCSO he worked as Department Recruiter as well as all regular patrol duties and did new hire background checks for them, as well.

Prior to PCSO Mark served in the US Navy from November 1986 until November 1994. He served aboard the USS Roanoke AOR-7, which was a "Wichita-class replenishment oiler." She sailed on two deployments to the Persian Gulf supporting Operation Desert Storm between January 1991 and August 1993.

During his time with LPD Mark has received many awards, including two Life Saving Awards and three Police Chief Commendations. He has served as a SWAT Crisis Negotiator, and a Hostage Negotiator for at least 21

years and even served as Team Lead. In addition, he has served on our Peer Support Team for 21 years (2004-2025) and was a driving force in the Peer Support Team being created.
